Although we strive to keep our tuition as low as possible, we understand that the expense of preschool may add strain on a family's budget.

Our scholarship fund is created through fundraisers and donations from people who care about children and believe that Pleasant Memories Preschool, LLC will minister to the community through a Christian preschool program that emphasizes Christian values and living, literacy development, diversity education and understanding, as well as preparing students for further and future education.

Scholarship Goals:

1. To provide preschool experiences for children starting kindergarten in the next school year whose families cannot afford full preschool tuition fees.
2. To further our mission of ministering to the community through a Christian preschool program that emphasizes Christian values and living, literacy development, diversity education and understanding, as well as preparing students for further and future education.
3. To help ensure economic and social diversity within the classroom.

Scholarship Guidelines:

1. Our scholarship fund is limited, and while all requests are considered, we cannot guarantee that all applicants will receive assistance. The Preschool Committee and the Administrator will review all applications and notify each applicant of their decision.
2. Your child must maintain an attendance of at least 80%. If your child's attendance drops below 80%, you will be given a notice. You will then have one month to increase your child's attendance. If your child's attendance is still below 80% after a month's time, your scholarship will be revoked.
3. If you receive a partial scholarship, your portion of tuition must be paid by the 1st of each month. If tuition is not received by the 7th day of the month twice in one school year, the Administrator will notify you and your child may not attend until tuition is paid.
4. If there are extenuating circumstances that would make it difficult for your family to meet the above conditions (vacations, change in finances), you may ask the Administrator for an exception to the condition. This request must be in writing for the exception to be considered.
5. Your signature below indicates both your commitment to pay your portion of tuition in a timely manner and your intent to send your child regularly to Pleasant Memories Preschool, LLC.
6. If your circumstances change, or if you have any question or concerns, please contact the Administrator.

Page 2 of this application will be kept confidential with the preschool Administrator. The remainder of the form will be confidentially used by the Preschool Committee and the Administrator only for the purpose of determining scholarship assistance.
